#### What it DOES include

Every student from your school who auditions for ANY **WMEA All-State** or **MENC All-Northwest** group will be allowed to apply at no charge.

#### What it DOES NOT include

**Student eligibility** for WMEA All-State (the appropriate teacher must still be an ACTIVE member, and students must still meet all published eligibility requirements).

**Student participation fees** for those accepted. Students from all schools will pay the same amount, whether or not the school is an associate member.

#### Who can use this membership

The following institutions that include students can apply this benefit to ONE designated school.
